If you are a member of the Greater Rome Board of Realtors® and your name does not appear on this list, you will need to complete a course for Code of Ethics before December 31, 2012 to comply with the requirements of the National Association of Realtors®.

**Code of Ethics training is a requirement of the National Association of REALTORS® every four years. We are currently in the third quadrennial cycle - January 2009 through December 2012.**

Mandatory ethics training requirements for new and continuing REALTOR® members was established by the National Association's Board of Directors at the 1999 Annual Convention to heighten member awareness of the key tenets of the Code of Ethics; to create an awareness of and appreciation for the role the Code can and should play in their professional lives; to enhance professionalism and competency; and to encourage REALTORS® to view their Code of Ethics as a living, viable guide in their daily dealings with clients, customers, and the public. This requirement went into effect January 1, 2001.

**Failure to complete the required periodic ethics training shall be considered a violation of a membership duty for which REALTOR® membership shall be suspended until such time as the required training is completed.**
